Since year 2000, CISE is accredited by SAAS to train SA8000 auditors and to supply SA8000 certification services.

Also, CISE started delivers BSCI (Business Social Compliance Initiative code of conduct by FTA – Foreign Trade Association) auditing services.

CSR services are supplied on a global scale, by means of a network of partners acting as inspection bodies. Certification decision are solely taken by CISE.

The network goes under the name of NETWORK LAVORO ETICO.

The design and implementation of SA8000 management systems by enterprises provides them with an opportunity for organisational innovation within a sustainable development model.

IMPRESA ETICA

Capitalising the experience in SA8000 and the direct knowledge of SMEs, CISE designed and developed the Impresa Etica system.

Impresa Etica is a standard (with sector-specific implementation guidelines) to be implemented by SMEs committing to continuously improve their CSR management.

Impresa Etica refers to a triple-bottom line concept of CSR (people, planet, profit) and takes into account the dimensions of https://www.nemanagement.consumers protection, engagement with stakeholders and the local community, tax paying and lawbiding behaviour, leadership and personal engagement by the entrepreneur.

Impresa Etica does not give evidence of compliance to a set of requirements, but of actual <u>commitment to continuous improvement</u>, on the basis of a self-assessment process, supported by specifically designed tool (guidelines).

Certification and/or verification of CSR standard or code of conduct implementation by means of on-field audits is a costly matter.

Most SMEs cannot afford such services.

On the other hand stakeholder demand independent surveillance and validation of enterprises' CRS efforts and performances.

The S.A.W. is a web-based platform specifically designed by CISE to lower the cost of CSR surveillance, while not relaxing monitoring.

S.A.W. relies on the active roles of stakeholders who can submit remarks to the Impresa Etica (as well as other standard) companies, that must address the remark by planning relevant improvement actions. Remarks are confidential and enterprises may prove them groundless if the case. CISE oversees the all process.

On-field audits are also on a sampling/SWAT basis.
